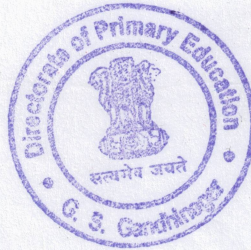


## NO OBJECTION CERTIFICATE

This is to certify that subject to following conditions the Government of Gujarat has "No Objection" to " SVP SECONDARY SCHOOL, OPP. LAKE VIEW GARDEN, PIPLD, SURAT run by SARDAR VALLABHBHAI PATEL EDUCATION TRUST, SVNIT CAMPUS, PIPLD, DIST.SURAT to be considered for affiliation to Central Board of secondary Education, New Delhi;

1. By virtue of issuing this NOC, the Government of Gujarat shall not be considered to be liable for any of the academic, administrative or financial liability of teachers, students or any other sort / circumstances of the proposed school.
2. Any kind of unhealthy competition with nearby schools by the proposed school may cause cancellation of this NOC.
3. The proposed school shall not use the premises including staff, playground or any moveable or immovable property of any other school registered under the respective Act of State Government.
4. Proposed school is bound to follow rules / norms of the affiliated Board. The State Government will not be responsible for breach of any of the rule / norm of such Board by the proposed school.
5. It will be responsibility of the proposed school to obtain all necessary permissions from the Government of India and/or such Board for which this NOC is issued.
6. The proposed school shall adhere to all the provision of RTE Act, 2009 and RTE Rule, 2012 and shall appoint only qualified and eligible staff as per the qualification laid down by the concern Board.
7. The proposed school and its records shall be kept open for inspection by an officer/official of the Board or an authorized representative of the Board/State Education Department at point of any time and the proposed school shall furnish information as may be asked by Board/State Government.
8. The proposed school is bound to adhere to the fees structure for the students as prescribed by the Gujarat State's Fee Regulation Committee constituted under Gujarat FRC Act/Rules, 2017.
9. According to the resolution dated 13/04/2018 of the Education Department, the Gujarati language education has to be implemented compulsorily.
10. The proposed school is bound and has to implement Resolutions/Circulars/Policies issued by the State Government/Education Department from time-to-time regarding school management, events, information and academic instruction.
11. Any point of time, if any of the document furnished by the Trust of the proposed school for the purpose of obtaining this NOC, found false or misleading or fraudulent, the issued NOC will be considered as cancelled.
12. NOC will be withdrawn for breach of any of the above terms and conditions.
