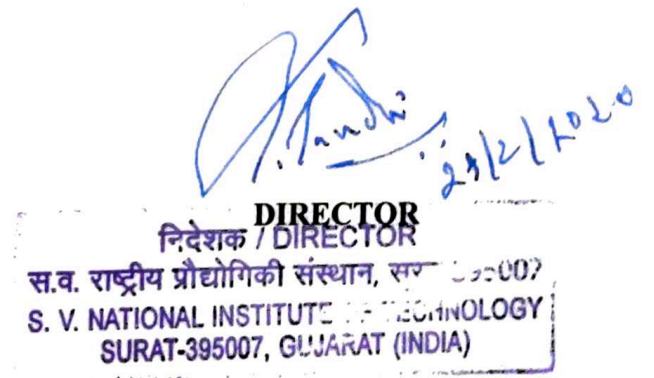
The **National Institute of Technology, Surat (NIT)**, formally known as Sardar Vallabhbhai Regional College of Engineering and Technology (SVRCET), Surat is an engineering institute of higher education established by the Parliament of India in 1961. It is one of 30 National Institutes of Technology in India recognized by the Government of India as an Institute of National Importance. Sardar Vallabhbhai Regional College of Engineering and Technology (SVRCET), Surat was established in June, 1961 as a cooperative venture between the Government of India and the Government of Gujarat. The institute is named after India's first Home Minister, fondly known as the Ironman of India, honorable Sardar Vallabhbhai Patel. A review committee (HPRC) was set up by the Union Government in 1998 for review of RECs. The Union Ministry of Human Resource Development, (MHRD) Government of India upgraded, all the seventeen Regional Engineering Colleges (RECs) to National Institutes of Technology (NITs). On 4th December 2002, the institution was granted Deemed University status with the approval of the UGC/AICTE and was as renamed as Sardar Vallabhbhai National Institute of Technology. NIT Surat is governed by its *ex officio* visitor, the honorable President of India and the NIT Council who head the NIT organizational structure. Under the NIT Council is NIT Surat, Board of Governors consisting of 10 members that includes representatives of the state of Gujarat, MHRD in addition to other members appointed by the NIT Council and the institute's senate. The Director serves under the Board of Governors, and is the school's chief academic and executive officer. Under the director and the deputy director are the deans, heads of departments, registrar and Chief Hostel Warden.

As a part of Social services, in 1976, SVNIT has formed one trust known as SARDAR VALLABHABHAI PATEL EDUCATION TRUST (SVPET), to impart school education to the wards of staff members of SVNIT and also to the economically/ financially needy students. The Honourable Chairman of the Board of Governor of Sardar Vallabhbhai Regional college of Engg. & Tech., Surat granted permission to start the Primary School in Jivabhai Bungalow (Vide C/ 100/471dt:20/05/1976). Under the said permission, the first standard was started in June 1976. The school then sought affiliations with Surat Jilla Panchayat, Surat. For getting such affiliation, the management body must be registered under

Bombay Private Trust Act, 1956. As a result, an education trust came into existence which is registered under its registration no. **I 1549/Surat** with office of Charity Commissioner, Surat. The School Board of Primary Education, Surat Jilla Panchayat, Surat unanimously granted affiliation to the school in Nov. 1976. (Refer – Annexure-1). Construction of School was started in 1997. On August 2, 1997, Prof. A.R. Jariwala, Chairman : SVP Education Trust and Prof. A. J. Shah, Chairman : Staff club, SVRCET requested to the Hon. Shri Bhagubhai Patel, Chairman : Board of Governors, SVRCET to grant permission to construct a new school building. (Refer- Annexure -2). This request letter with recommendation of the 39th meeting of Standing Executive Committee held on 07/08/1997 and was considered by the Board of Governors (BoG), SVRCET at its 107th meeting held on 28/08/1998 considered. (Refer Annexure-3). As per BOG Resolution No.12 of 107th meeting held on 28/08/1998, new building construction of SVP School was started on plot no. 98 (as per SMC town planning scheme) near Sharda Yatan School in construction with faculty I/C Estate Section. (Refer- Annexure-4). As per present practice SVNIT, don't need any permission from SMC, Surat, however, SVNIT, Surat informing to SMC, Surat. SVP School is also part of SVNIT, Surat; so, permission is not required from SMC. All the construction activities, if any are always monitored by the SVNIT experts and other officials.
